ANDREW W. MELLON FOUNDATION AWARDS GRANT TO MUSEUM OF THE MOVING IMAGE TO SUPPORT THE PRESERVATION AND CONSERVATION OF BORN-DIGITAL MEDIA

Planning grant supports initiative to establish techniques and technologies for the long-term preservation of born-digital objects and to allow for new directions in collecting

Astoria, Queens, NY, October 5, 2017—Museum of the Moving Image (MoMI), the nation's only museum dedicated to film, television, and digital media, has been awarded a grant in the amount of \$375,000 from The Andrew W. Mellon Foundation to support the creation of a sustainable institutional infrastructure for the preservation of born-digital works, while also developing a high-quality model that elevates practice throughout the field. With such a framework established, MoMI will be able to collect and preserve digital material relating to film and television production, and digital artwork, such as the animated GIF commissions supported by Giphy currently on view in *The GIF Elevator* installation at the Museum. The Mellon-funded project will eventually extend to social media platforms and virtual reality.

"Because they are made out of bits and bytes, these 'objects' are often created, manipulated, and viewed digitally, requiring brand new preservation strategies and technologies," said MoMI Executive Director Carl Goodman. "We are honored by this award from The Andrew W. Mellon Foundation. For the past two decades, the Museum has been at the forefront of exhibiting digital media works, from early video art to video games and animated GIFs. This grant will enable us, for the first time in our history, to have an infrastructure for the collection and preservation of such work."

The grant project, "Born Digital: Pathways Towards Preservation," will be led by Barbara Miller, Ph.D., Senior Curator of Collections and Exhibitions, with support from other Museum staff. The heart of the Museum's collection—2% of which is on view in the core exhibition *Behind the Screen*—focuses on the objects created as part of the process of making, promoting, and distributing film, television, and digital media. These include set models, production equipment, and publicity materials. Miller said, "This is a fantastic opportunity for the Museum to build capacity for collecting, preserving, and exhibiting recent forms of digital art and vernacular culture, as well material that is now likely to be born-digital instead of physical, such as costume and production designs, and other artifacts of production." The Museum has partnered with Small Data Industries, a conservation studio and consultancy founded by Ben Fino-Radin, to conduct activities including a review of current institutional practice; a series of case studies offering in-depth materials research; developing a pilot digital preservation repository for the collection; and facilitating dialogue with colleagues at other museums, libraries, and universities facing similar challenges in the conservation of born-digital art and cultural heritage.

"Ensuring the longevity of born-digital content is essential to preserving the cultural record of our time. With this grant, the Museum of the Moving Image will take an important leap forward toward embedding the necessary infrastructure to make the responsible stewardship of this material mission-critical," said Alison Gilchrest, Program Officer for Arts and Cultural Heritage at the Andrew W. Mellon Foundation.
